3.5 I would like to bring to everyone's attention that the Maricopa Community Foundation (MCF) claimed that they never received our applications for grants.

I submitted three applications for three non-profit organizations. Chrystal uploaded the applications onto the MCF website and I hand delivered the applications to City Hall. After we resubmitted, the applications were Denied!!! To add insult to injury, I was offered a position on the MCF Board!

I told them that I was not interested. That grants was only 1K. It's the principle.

3.6 Chrystal and I have put a deposit on the GALA venue. We are planning to hold the Gala at the Paramount Theater in Casa Grande.
